### NOTES:

- Life Membership of the Ferntree Gully Cricket Club was first conferred at the 1937 Annual Presentation Night (held in May 1937 at the Ferntree Gully Shire Hall), when the Club retrospectively conferred the first three Life Memberships and then later at the 1937 A.G.M. (September) conferred the honour on Noel Sandford.
- In May 1996, the Club altered the constitution allowing multiple Life Memberships to be conferred
- At the 2015/16 Annual General Meeting (May 2016), the Club introduced a second tier of Life Membership: "**Associate Life Membership**", to recognise those members who made a significant contribution (equivalent to Life Membership), in the fifty two seasons before 1934, when the initial Honorary Life Membership was bestowed. The ten "**Associate Life Members**" posthumously honoured for their contributions between 1882 and 1934 were F.J. Charman, J.G.S. Ford, T.S. Grimwood, E.E. Lording, G.A. Lovell, H. Monk, A.R. Pickett, A.E. Selman, F.N. Stevens & G.J. Williams.

### CONFERRING LIFE MEMBERSHIP AT THE FERNTREE GULLY CRICKET CLUB

Life Membership of the Ferntree Gully Cricket Club is conferred at an AGM when the Club Executive, having earlier determined any suitable nominations, puts forward a recommendation to those in attendance at the Meeting, that the nominee(s) be considered for Life Membership.

With the nominee(s) asked to leave the room (if present), the attendees discuss and then vote on the acceptance/rejection of the Executive nomination.

The Life Membership medallion for any accepted nominee(s) is then awarded to the recipient(s) at the next Annual Presentation Night, i.e. held at the end of the following cricket season.

A Life Membership may also be nominated when seconded in writing, by two current Life Members.

Their nomination also has to be passed by the Committee for selection and nomination at the AGM and must also be voted on by the members through the process defined above.

**The Life Membership Honour Board was donated by the Kirkpatrick family in 1961 & extended in 2016**
